Qualitative analysis of Criterion 1

Krishna Chandra College is one of the affiliated institute of University of Burdwan established with a prime objective and emphasizing on offering quality education in a rural environment at Post Matric Education level. The institution has been catering to the needs of the students coming from surrounding villages. The institution involves students in various extension activities, and community services of the rural society.

The institution has a well-planned academic calendar at the beginning of every academic year by following the system of Continuous Internal Assessments (CIA) through various measures to have a comprehensive evaluation and level of students. The institution is providing opportunity to have academic competence and additional knowledge and information through various certificate and add-on courses. The institution is to conduct regular field visits and visit to other organizations to provide the knowledge on various practical challenges. The career counselling cell has some collaborations with some companies and organizes placement sessions, where selected students get an opportunity to do internships with those organizations.

The institution has a mechanism for feedback system from all the stake holders (Feedback from students, Feedback from parents, teachers, employer, and alumni). These feedbacks used to be analysed and viewed from all the stakeholders will be utilized in a positive way by the institution to identify the shortcomings and rectify them in the future. Every department has been involved in organizing the parent-teacher meetings to discuss the shortcomings of the students and what could be done better in future. Many of the staff members are involved in various academic activities of the University like question paper setters in the University examinations. The syllabus prescribed by the University from time to time is being followed through an effective delivery and documentation by the institution.

It is necessary that the institution needs to encourage and provide training in soft skills to students, through workshops in leadership training, and the students are need to be encouraged for innovation in their respective subject of learning through latest knowledge and information.

Qualitative analysis of Criterion 2

The institution performs the process of admissions with transparency and in compliance with the state government and affiliating University rules, regulations and guidelines.

The institution provides equal opportunity to the students irrespective of their class, caste, and religion and caters to the needs of the students. The college used to communicate the information regarding the academic and other activities to the students through social media. The students are guided closely by the mentors regularly through the departmental mentor-mentee groups, with a feeling that efficient communication helps the institution to understand the satisfactory levels of students and giving scope for improvement.

The institution aimed at adapting time to time the modern pedagogies and equipment to make learning outcome to be fruitful. The institution has been practicing with the student-centric methods like experiential learning, participative learning, and problem-solving methodologies to enhance the learning experiences, which in turn enhance students' involvement through various academic activities like seminars, quiz competitions, publishing wall magazines, educational tours as well as through extra-curricular activities like sports, various cultural activities and programs organized under NSS and NCC. The institution implementing the ICT-enabled tools very effectively for making the teaching-learning process to be effective and all the faculty members are active in utilizing the same. The faculty members are well qualified in their respective subjects and around 55% of the faculty members are holding PhD degrees.

The Internal Assessment is an integral part of the curriculum and the institution conducts CIA to understand the comprehension level of understanding of the students. The institution follows in having academic and examination committees to ensure systematic and efficient functioning of the academic as well as evaluation processes. The student's performance is well monitored through various academic departments and accordingly effective measures are taken to improve the student's academic performance, and the pass

percentage of the students is around 83%. The institution provides stimulating environment that encourages critical thinking, creativity, and practical application of knowledge. Trying to provide the teaching methodologies as innovative and student-centric.

It would be more relevant and useful, if arrangements are made more students' internship with industry training, if it is given due consideration and preference for academic development of the students. It is suggested to initiate more job oriented skill development and vocational courses for immediate employment opportunities.

Qualitative analysis of Criterion 3

The institution has created a research environment by developing research culture integration with teaching, learning process along with finding solutions to issues of societal concern.

The college has established a Research Sub Committee to manage research and development among the Teaching faculty. Some of the faculty are recognized research supervisors of the University, three faculty members from Bengali, Economics, and Zoology, recognized as research supervisors. The institution has been motivating the faculty for undertaking research across the diverse fields, contributing to the society. And institution has good percentage of teachers having PhD qualification (54.5%).

The institution has been involved in organizing the regular seminars, lectures, and webinars for motivating the faculty and students to the dynamic facets of the subject knowledge and create innovation among them. During the pandemic time, the college has provided institutional mail addresses and G-Suite accounts for staff, and facilitating them for the advancement of technology.

The college also features a well-stocked digital library with access to open educational materials, E-magazine subscriptions, E-resources, and career counselling tools. The college has been equipped with well furnished laboratories and teachers are motivated to provide an appropriate learning environment for innovation. The college has organized few workshops and talk series on various socially significant issues, such as education, human rights, mental wellbeing, and Intellectual Property Rights. The institution used to organize educational excursions and fieldtrips as a part of the course curriculum, to provide awareness and knowledge on the

subject and to provide recreation and instilling confidence.

The NSS and NCC branch of the college has been involved in organizing awareness campaigns, special camps, and cleanliness campaigns to get awareness for students selflessness, character development, leadership skills, and patriotism. The college has also been providing awareness on environmental hazards and has taken steps to harvest rain water and follow a biodegradable waste management system, with a feeling that these practices create an environment for innovations and cultivate the Indian Knowledge System.

However, it is necessary that all the faculty members need to be encouraged to apply for extra mural research funding and publish more quality research papers for developing research culture. It is necessary that the Research collaboration through MoUs also needs to be encouraged. The institution has to encourage to establish Incubation Centre and Industry Academia & IPR cell for the benefit of students and teachers

Qualitative analysis of Criterion 4

The institution has reasonably good infrastructure for teaching, learning, academic atmosphere and for effective administrative functioning of the institution with 2794 students from different parts of the region. The institution has been spread over the area of 4.00 acres in a rural area with clean and green environment and having built up area 7000 sq mts. The college is well-equipped with modern facilities, including classrooms, ICT resources, and learning materials.

The college has provided ample physical infrastructure, such as equipment, books, ICT facilities, consumables, furniture, and teaching aids. Additionally, plans have been made to upgrade and enhance the existing infrastructure in future. The safety measures has been taken prominently, and a barrier has been installed at the main entrance, along with a security.

The main campus houses the Central Library, which contains books from various disciplines. The library of the college has been established in 1897 and it is automated using Integrated Library Management System (ILMS)namely, CAMS 3.0 since 2018. Web OPAC Library system is running in thelibrary which provides different library resources. The Library is having two spacious halls and two rooms including Reading Room, Reference Section, and Text Book Section. The library has collection of 39278 books at present and number being increased every year. The CCTV cameras are installed in library and throughout the building's corridors.

The ICT-enabled tools for the effective teaching-learning process is being used. To make use of these ICT tools, the faculty members keep themselves updated about new developments in this field. Almost all the teachers of the college are well-equipped and trained in using ICT-enabled teaching tools for facilitating the teaching-learning process. Institute premises is Wi-Fi enabled with a band width of up to 75 MBPS. Latest software is being used by many science departments such as Mathematics, Chemistry, and Physics. The institute has 100 systems and 22 printers being used in different departments and offices.

The institute has 42 classrooms, out of them 13 class rooms are ICT-enabled. There are two seminar halls with ICT facilities. One LED TV and two Interactive boards. The laboratories are available for all science departments.

However, establishment of a separate digital library with more number of e-books and journals and e-books with remote access facility for the benefit of students and teachers, is the need of the hour.

Qualitative analysis of Criterion 5

The institution claims that it is supporting the development of rural and remote area students, and their academic progression and providing help for their development. The institution has been extending helping hand to uplift the poor socioeconomic backward students of the region.

The institution has in place various committees and cells, like the Career Counselling and Placement Cell, Students Cell, Grievance Cell, etc. The institution has a mechanism to help the students and to maintain continuity in the application and disbursement of scholarships from several Government schemes. The college used to maintain the student's records systematically, and to guide the students about the various schemes, and many students are benefitted from the student support schemes. The institution has a certain policies in place to waive the fees of students who come from economically backward communities.

The Institution has been arranging some employability skill development programs, career counselling programs as well as placements and helping students for future progression. The students also been receiving career guidance at departmental levels through their department mentors. The institution used to organize some subject-specific seminars, to help them to get awareness on various opportunities and further their progression to higher studies.

The Institute regularly organizes annual program for encouraging the students who performed very well and their efforts in that process, has led to increase the percentage of students' progression to higher education many have cleared competitive exams. The institution utilizes the alumni very effectively and they play a vital role in mentoring current students. The institution has a registered alumni association.

The institution needs to attract the proactive role of the alumni for enhancing the institution development, infrastructural development, collaborations and campus placement of students.

The main objective and fundamental criteria is to attain quality in teaching, learning, and research with critical mass; demographic diversity; internationalization and international collaboration; cross-discipline programs; flexibility and mobility for students; academic freedom; 24x7 IT access for modern information; interinstitutional collaboration; anda push for research aptitude.

The governance framework of the University, which is being followed as per the traditional model common to all Indian Universities and adheres to the regulations set by the UGC and University. To ensure ongoing growth and improvement in educational quality, it is necessary that effective governance requires distinctive management approach that is not only democratic and consultative but also inclusive of all the stakeholders for the further development of the institution.
